Primary data: meaning and methods of collections-survey research (interviews and questionnaire design), observation research (direct and indirect). Secondary data: meaning and sources.

Unit-IV

Qualitative research: meaning and uses; orientations to qualitative researchphenomenology, ethnography, grounded theory and case studies; techniques of qualitative research-focus group interviews, depth interviews, conversations, observation and thematic appreciation test.
